## FROM THE MEMBERSHIP SECRETARY:

2010 Dues Statements were sent to you in November. If your dues are not paid by January 31, you will be dropped from National and Local membership. As of January 31, your children will not be able to continue with basketball, gymnastics or bowling, if you elect not to renew membership. Should you be reinstated, it will be 90 days from reinstatement before you will be able to participate in District or National functions. Because of the early notice of the dues fees, there will be no exceptions. If you are not intending to renew your dues for 2010, please indicate that on the dues statement so that you can be dropped In Good Standing. Dues statements and money may be turned in to the bartender or mailed in the envelope that was enclosed with your Statement. There is a discount for members who have been Turners members 15 years and who are 60 years old.
